# **SECTION 2 — HAZARDS IDENTIFICATION**

Hazard class: Oxidizing liquids; Oxidizing solids (Category 2). May intensify fire; oxidizer (H272). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).

# SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #3. Store with amides, nitrates, nitrites and azides.

Store in a dedicated acid cabinet and away from any source of water; if an acid cabinet is not available, store in a Flinn Saf-Cube<sup>TM</sup>. Never store with acetic acid. Keep and store away from clothing and combustible materials (P220). Take any precautions to avoid mixing with combustibles (P221). Use only in a hood or well-ventilated area (P271).
