- Lianna shared Academic Senate is giving the first 50 people to register for graduation a gift card.
- Grace shared IPBT heard updates from College Council, heard an idea about creating handbooks for better processes in the future, and went through the processes and hiring documents for the faculty positions.
- Kimberly shared College Council discussed the Shared Governance Group Taskforce presentation from JMRR about the survey sent out, they voted on 9 faculty hiring positions, discussed why the way they voted this time will never happen again, and had a Facilities Taskforce presentation.
- Lianna mentioned the Facilities Taskforce presentation did not include statistics about disabled students and was told to look for them online, but she concluded they were not online.
