The College Planning Committee (CPC) would like to propose two items to College Council for review pertaining to De Anza's planning processes.

1. Align the Planning Quilt with the seven-year Accreditation Cycle - De Anza College will undergo a site visit by ACCJC in fall 2017, at this time the accreditation cycle begins at year one and continues for seven years. In the past, our planning cycle has been aligned with the accreditation cycle, as both were on a six-year cycle. In order to adjust to the seven-year cycle, changes will need to be made to the planning quilt. Our current cycle is:

Option 1: Comprehensive Program Review Every Six Years

Departments/divisions undergo one Comprehensive Program Review per cycle with the Comprehensive being on the same year as the accreditation Mid-term Report. In this case, the Comprehensive will reflect on six years of data. The Year of Reflection shall be completed in the fall following the Comprehensive. This option will align the Comprehensive with the revision of the Educational Master Plan and Mid-term Report.

4. What changes should be made to the program review process or questions to improve student learning?
